<p><b>COVID-19 Disaster Payment</b></p>	<p>A payment for workers who have been unable to earn income due to the COVID-19 lockdown. For workers not already receiving income-support, there are two tiers of payments depending on number of work hours lost (according to the dates and locations outlined in the following column):</p> <ul style="list-style-type: none"> <li>• \$325/\$375/\$450 if you lost 8 -20 hours of work per week or a full day of your usual work hours</li> <li>• \$500/\$600/\$750 if you lost more than 20 hours per week</li> <li>• People already receiving income-support who have lost more than eight hours of work a week will get a special disaster supplement of \$200 a week.</li> </ul>	<p>Amounts refer to payments to workers who lost 8-20hrs of work / more than 20hrs of work, respectively.</p> <p>For inner-Sydney residents*:                      1 July-14 July 2021: \$325/\$500pw                      15 July-4 August 2021: \$375/\$600pw                      From 5 August 2021: \$450/\$750pw</p> <p>For the rest of Greater Sydney**:                      4 July-17 July 2021: \$325/\$500pw                      18 July-7 August 2021: \$375/\$600pw                      From 8 August 2021: \$450/\$750pw</p> <p>For the rest of NSW:                      18 July-7 August 2021: \$375/\$600pw                      From 8 August 2021: \$450/\$750pw</p> <p>Existing recipients of income-support may receive \$200 per week.</p>	<p>Weekly following application</p>	<p><a href="#">Visit the Services Australia website</a></p>	<p><a href="#">Apply here</a></p> <p>Claims for the week of 1 July close on 28 July 2021 and weekly thereafter, e.g. claims for the week of 8 July close on 4 August 2021 and so on.</p>
<p><b>Support with my tenancy</b></p>	<p>Protection from eviction for residential tenants who have suffered a 25% or more loss of income due to the lockdown.</p> <p>Land tax relief or grants for landlords who reduce the rent of lockdown impacted tenants.</p>	<p>Land tax relief is provided to landowners who reduce rent for COVID-19 affected tenants between 1 July and 31 December 2021 up to 100% of their 2021 land tax liability. Landowners who do not pay land tax can alternatively apply for up to \$1500 grant per residential tenancy.</p>	<p>Most payments will be made within 14 days of the application being assessed.</p>	<p><a href="#">NSW Fair Trading</a></p>	<p>Speak with your landlord and direct them to NSW Fair Trading</p>

To be eligible your business or organisation must have a turnover between \$30,000 and \$75,000 per year, and your revenue has declined by 30% or more
